

Terms and Conditions

Welcome to Camp Grace Outdoor Play Area. Please read this document carefully. It affects your legal rights in the use of the facility in the event of injury or other loss. This document must be signed by all adults (18 years and older) participants and/or by a parent or guardian of a minor participant. The parent or guardian, referred to in this document as Parent, agrees to these provisions for himself or herself on behalf of the minor child.

By signing this waiver, the participant and/or guardian accepts that there are inherent risks and hazards in adventure play and obstacles and agrees not to sue the CAMP GRACE organization and proprietors. Please read and sign the following agreement:

I, as a participant or parent/guardian of a participant, understand I will be participating in activities that involve heights, pulling and climbing. I know to watch out for slippery and/or uneven footing, limbs and branches, insects or animals and possible exposure to extreme or inclement weather, I fully understand that my physical activity involves risk of injury. I understand the risks may include loss or damage to personal property.

I agree to comply with safety recommendations and will be responsible for my personal safety and well-being. I agree to hold CAMP GRACE, its Directors, Officers, Employees, Agents, and/ or Associates harmless for any accidents, injury, loss of or damage to property that may occur on Outdoor Play Area. I understand that all possible precautions are taken to ensure that all programs and activities occurring at CAMP GRACE are conducted by mature and qualified personnel in a safe and responsible manner. I voluntarily assume the risks of the activities and agree to report any injuries before leaving the premises. In the event of an emergency, I understand every attempt will be made to contact the parent/guardian. In the event that the parent/guardian cannot be reached, I give permission to CAMP GRACE or your camp representative, to secure proper medical treatment. I understand that CAMP GRACE is not responsible for any medical treatment costs. I have read and understand all materials outlining the Outdoor Play Area, including this waiver and agree to abide by these terms. I am aware this is a waiver and a release of liability and I sign it voluntarily.

If a session is canceled by Camp Grace, the full fee will be refunded. Campers may withdraw from the program up to 42 days in advance and will be given a full refund. Cancellations made after 42 days prior to the start date, will not be entitled to a refund. Any payments made (deposit or full payments) after this time will not be refunded.

Campers are suspended from camp if they bring any of the following items: vape pens, drugs, tobacco, alcohol, firecrackers, weapons, or other dangerous instruments. Campers may also be sent home if they are out of their cabin at night, have pre-existing behavioral or medical conditions that were not communicated to camp, or engage in criminal or sexual behavior. Inappropriate language is not tolerated. Within the camp's discretion, a camper who is suspended may be allowed back in a subsequent session.

Please do not bring or send candy, gum, or other foods to camp. Campers will have the option to purchase snacks/drinks from the Snack Shack. No food is allowed in the bunks.

The camp policy regarding campers calling home is based on the understanding that phone calls can be the most challenging form of contact for campers. Our camp environment is a happy, self-contained community. Phone calls often create a sudden intrusion causing campers to experience feelings that override the good intentions that motivated the phone call. Hearing a parent's voice can be difficult even for a well-adjusted camper. So, we do not encourage phone calls. *Unless a call has been scheduled by parents, campers are not allowed to call home. *You can always call the office to check in on how your camper is doing, and our unit heads are always available to update you about your camper's progress.

Driving into camp, you will notice a sign that reflects our aspiration for campers: "At Camp Grace, we unplug so we can really connect." To this end, we are a screen-free camp, and devices with screens are strictly prohibited. This includes phones, tablets, kindles, iPods, cameras, handheld game systems, and all other devices with screens. Any camper using a cell phone (or a device to access the internet) will have the device confiscated and returned after camp. If there is a second violation, the camper will be suspended for a day. Parents will be required to pick up and return the camper at the parents' expense.

We strive to protect everyone at Camp Grace from bullying. In addition to creating a culture of kindness, Camp Grace has a three-strike policy for bullying behavior. For the first incident, the offending camper will participate in a meeting with camp leadership staff. If there is a second incident, the camper's parents will be notified. If there is a third incident, the camper will be sent home.

Valuables: Please do not let your child bring any valuables to camp. If you would be upset if a particular item is lost or broken, the item should stay at home.

Each camper must be in the range of sight or hearing of a staff member at all times. Our top priority is keeping campers safe and healthy, followed closely by ensuring they have a fun, friendship-filled, and memorable summer.

Campers may be recorded and/or photographed for promotional/marketing purposes as well as to send parents camp updates. No personal information will be used for promotional/marketing purposes.

Our dress code helps maintain a safe and comfortable environment. We reserve the right to ask anyone to change if deemed necessary by the camp staff. Footwear: During the day, campers are required to wear socks and closed-toed sneakers. This prevents injury and enables campers to move freely around the camp. Campers may wear sandals to evening events. Tops and Bottoms: Clothing should not contain inappropriate slogans or images. We do not permit revealing clothing for boys or girls, including visible bra-straps, see-through clothing, crop tops with tummies showing, etc. Sunblock: Sunblock is part of our dress code – you aren't fully dressed without it!

Anyone who intentionally damages or defaces camp property is liable for such damage, and families will be charged accordingly. This includes writing names on cabins or beds.

To protect each camper's privacy, campers are only permitted in their own bunks. Under no circumstances may boys or girls enter the opposite gender's bunk. Campers may not bring cameras or take photographs in bunks, bathrooms, or other private areas.

All health and accident expenses will be covered by each family's medical insurance. Parents are responsible for providing proof of medical insurance for their children. If a provider does not accept your family's insurance, it is your obligation to pay the costs of the medical service. Please provide insurance information.

- Glasses: Please send a second set of glasses with each camper. Also, please make sure to indicate that he or she wears glasses or contacts on the registration form.
- Special dietary needs: If your child has any other special dietary needs, please let the camp office know now so we can work out a plan.
- Contagious disease: Please advise camp of any contact your child has had with any contagious disease after May 10th. If your child has a cough, cold, rash, fever, lice, conjunctivitis/pink eye, or any throat problem in the days before camp begins, please contact us so we can make a plan for when they can join us in good health!
- Sick campers: If your camper is feeling under the weather at camp, he or she will receive comforting and professional care. The camp is a few minutes from a

complete network of health care providers and roughly 5 minutes from a major hospital.

- When do we call home? We err on the side of contacting parents. We will always call to inform parents if: a camper has been in the Health Center overnight; before a camper has been placed on prescription medication, or a camper has been taken out of camp for medical care. Parents may not be notified if a child spends less than 24 hours in the Health Center or receives a routine diagnosis and treatment, which could include a cut, bug bite, sore throat, or headache.
- Camper health and safety orientation: All campers will receive a health and safety orientation at the start of camp, which covers topics including daily hygiene and handwashing, food safety, Lyme disease prevention, appropriate behavior and relationships, safety rules, and what to do in the event of an illness or injury.

1. In consideration for participating in any Camp Grace Program/Class and other valuable consideration, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Camp Grace/Mission of Grace/Partners in Action/Brimhall Family Foundation, (hereinafter referred to as CAMP) at 6358 W White Mountain Blvd, Lakeside, AZ 85929, from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, or sickness, including death, that may be sustained by CAMP, or to any property belonging to CAMP, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity/event is being conducted or in transportation to and from said premises.
2. To the best of my knowledge, I, or my child, can fully participate in this activity/event. I, or my child, am fully aware of risks and hazards connected with the activity, including but not limited to the risks as noted herein, and I, or my child, hereby elect to voluntarily participate in said activity/event and to enter the above-named premises and engage in such activity/event knowing that the activity/event may be hazardous to me. I, OR MY CHILD, VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, SICKNESS, INCLUDING DEATH, that may be sustained by me or my child, or any loss or damage to property owned by me or my child, as a result of being engaged in such an activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise.
3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage, or costs, including court costs and attorney's fees, that may incur due to my, or my child's participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.

4. It is my express intent that this Release and Hold Harmless Agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns, and personal representative, if I am not alive, shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Arizona.
5. I UNDERSTAND THAT CAMP GRACE WILL NOT BE RESPONSIBLE FOR ANY MEDICAL COSTS ASSOCIATED WITH AN INJURY OR SICKNESS I OR MY CHILD MAY SUSTAIN.
6. My child and I further agree to become familiar with the rules and regulations of CAMP concerning student conduct and not to violate said rules of any directive or instruction made by the person or persons in charge of said activity/event and that my child and I will further assume the complete risk of any activity done in violation of any rule or directive or instruction.
7. I also understand that I should and am urged to obtain adequate health and accident insurance to cover any personal injury to myself or my child which may be sustained during the activity or the transportation to and from said activity/event.
8. I ALSO UNDERSTAND THAT I AM RESPONSIBLE FOR ANY DAMAGE I OR MY CHILD CAUSE TO THE FACILITIES. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

I grant permission to CAMP GRACE, its agents, and its employees the irrevocable and unrestricted right to produce photographs and video taken of my child, myself, and members of my family while at CAMP GRACE for any lawful purpose including publication, promotion, illustration, advertising, trade, or historical archive in any manner or in any medium by CAMP GRACE. I hereby release CAMP GRACE and its legal representatives from liability for any violation or claims relating to said images or video.

Furthermore, I grant permission to use the statements of my child, myself, or my family members given during an interview or evaluation with or without my name for the purpose of advertising and publicity without restriction to time limit or geographic area. I waive my right, my child's rights, and my family's rights to any and all compensation stemming from the use of these materials.

At times it becomes necessary to use private vehicles to transport students to and from Camp Grace activities. When this occurs, Camp Grace/Project Elevate requires that the student sign a Private Transportation Release Consent Form.

By signing this agreement, I hereby release Camp Grace/Project Elevate, as well as its directors, officers, administrators, employees, or other agents from all liability or damages for any and all injuries arising from the negligence of any of the above while traveling to this activity via private transportation.

Camp Grace/Project Elevate must have this signed form in their possession prior to the date of the specified activity.
